**FIRST AMENDMENT TO
 AGREEMENT FOR ARBITRAGE REBATE COMPLIANCE SERVICES**

This FIRST AMENDMENT of the AGREEMENT FOR ARBITRAGE REBATE COMPLIANCE SERVICES is made and entered into by and between FORT BEND COUNTY, TEXAS, a body politic, acting herein by and through its Commissioners Court and Arbitrage Compliance Specialists, Inc. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

RECITALS

WHEREAS, on or about August 22, 2017 the Parties entered into the AGREEMENT FOR ARBITRAGE REBATE COMPLIANCE SERVICES which is incorporated by reference;

WHEREAS, the Parties now desire to amend a certain portion of the Agreement; and

NOW THEREFORE, for and in consideration of the mutual benefits to be derived by the parties hereto, County, and Contractor agree as follows:

I. Amendments

- A. Section 4, Limit of Appropriation, is amended to add an additional \$2,150.00 to the total maximum annual compensation that Contractor may become entitled to under the Agreement. The Parties agree that Section 4 shall now read:

Contractor does further understand and agree, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum annual compensation that Contractor may become entitled to for capitated fees, unless there is an increase in enrollment, and the total maximum sum that County may become liable to pay to Contractor shall not under any conditions, circumstances, or interpretations thereof exceed \$22,150.00.

- II. Except as modified herein, any prior executed document remain in full force and effect and has not been modified or amended. In the event of conflict, the contents of this First Amendment shall prevail.

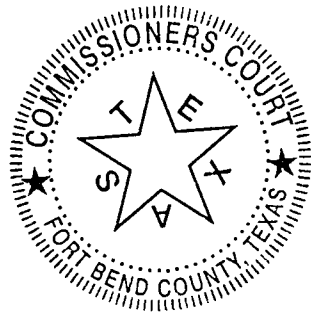
III. Execution
