Mr. Jim Short, Legislative Consultant, explained the steps of how a bill is introduced, reviewed the County process of interacting with the members of the legislature and the County's legislative team and the Austin process in passing legislation or keep from passing. Mr. Short indicated the process, in general, is set up for things not to happen. The reason there are many steps is because the goal is to minimize the number of things that can happen, which has been the policy of legislative leadership for many years. In order to pass bills for the County, there are steps to take, such as: Find a sponsor, the Bill must be drafted by the legislative council, the Bill must be passed by both the House of Representatives and the Senate in identical form, the Bills must be sent to the Calendar Committee, deadlines must be met, such as the deadline for introducing bills is in early March and having unanimous resolutions are important.

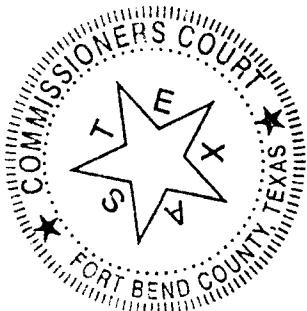
