

1. All merchandise sold under this agreement is warranted by McCoy-Rockford, Inc. (hereinafter referred to as "Seller") to be free from defects in materials or workmanship for a period of twelve (12) months from date of delivery to buyer. If the merchandise sold hereunder is defective on account of workmanship or material, Seller agrees to replace the merchandise, or, at Buyer's option, to repair the defective merchandise to the satisfaction of the buyer. This agreement is contingent upon Buyer promptly notifying Seller in writing of any claim in respect to defects in the merchandise, setting forth the specific defect in the merchandise, and affording Seller a reasonable opportunity to examine the merchandise and investigate the claimed defect. Except as noted herein, SELLER IN NO EVENT SHALL BE LIABLE FOR DAMAGE BEYOND THE PRICE PAID BY BUYER FOR SUCH DEFECTIVE MERCHANDISE. This warranty is in lieu of all other manufacturer warranties, express or implied, and it is agreed that, except as noted herein, there is no express or implied warranty by Seller as to the fitness or merchantability of any merchandise sold, and that there are no oral or implied additional warranties made in connection with the sale of merchandise sold hereunder.
2. No items will be accepted for return without prior approval, and all returns are subject to a restocking charge.
3. All merchandise specially manufactured or not regularly stocked that conforms to the specifications outlined is non-returnable.
4. If a contract for specially manufactured merchandise is canceled after work is started, Buyer will pay for work done to date Seller receives cancellation.
5. The merchandise shall be subject to reasonable variation from standard in color, quality, finish and variations allowed by the trade customs of the industry.
6. Seller shall not be liable for any failure, delay or interruption in the performance of this contract which is occasioned by causes beyond its control, including, but not restricted to, fires, floods, strikes, lock-outs, labor disputes, accidents, interruptions in transportation services, shortage of raw materials, failure to obtain delivery from manufacturers, any ruling, regulation or law of any governmental bureau or agency, or any other cause giving rise to total or partial stoppage to Seller's supplies. Delays so caused shall not release Buyer from its obligations to accept and pay for the merchandise. Buyer cannot cancel order without prior written approval of Seller.
7. After delivery of merchandise by Seller to Buyer, all risk of loss or damage shall pass to Buyer, including, but not limited to, any loss or damage by either, other trades such as painting or plastering, telephone installation, fire or other elements and Buyer agrees to hold Seller harmless and indemnify Seller from loss for such reasons.
8. The purchase price is based on the installation being made during the normal eight-hour, five-day workweek, (Monday through Friday), except holidays. If installation is required at times other than these, it will be done, at premium time rates, and Buyer shall reimburse Seller the amount by which such premium time rates exceed normal rates. Additional installation charges will be billed to Buyer if free and ready access to job site is not provided by Buyer.
9. Buyer agrees to pay Seller in full for any portion of the merchandise Buyer has received and accepted. Payment cannot be withheld until an order is complete. Upon delivery of any portion of the merchandise, Seller will invoice Buyer for that amount of the Purchase Price relating to the delivered portion of the merchandise. Buyer agrees to pay each invoice consistent with the terms indicated herein. Interest on the unpaid portion of the invoice shall accrue at the highest rate permitted by applicable law. In the event that Seller retains an attorney to collect any past-due payments, Buyer agrees to pay reasonable attorney's fees, plus court costs, arbitration fees and expenses and disbursements, to the extent permitted by law.
10. All furniture ordered in a quantity of truckload or more will be shipped direct to jobsite for installation. If buyer is not ready to receive merchandise, merchandise will be stored at Seller's warehouse at Seller's current storage rate per 30-day period or portion thereof. All furniture ordered in quantity of less than truckload can be received and stored at Seller's warehouse for 30 days without additional storage charges to buyer. After the initial 30 days, Seller's current storage rate will be charged for each 30 day period or portion thereof. In the event that merchandise is brought back to Seller's warehouse from the job site, Buyer/Contractor agrees to pay storage charges starting upon the date of receipt in Seller's warehouse even if Buyer/Contractor has not issued a purchase order for such storage charges. (Exclusive of manufacture or order errors.) Double handling will be charged for all merchandise redirected to Seller's warehouse.
Upon notification to Buyer that merchandise has been received by Seller, Seller will invoice Buyer in full for merchandise and current storage rate, and Buyer hereby agrees to pay ninety percent (90%) of the invoice price for the merchandise within fifteen (15) days of invoice date, and pay the remaining ten percent (10%) upon installation.
11. Title to and ownership of all merchandise remains in Seller's name until fully paid. Buyer shall be in default under this contract if there is default in payment or performance of any obligation contained or referred to herein. In the event of such default on the part of Buyer, or if Seller deems payment of Buyer's indebtedness to Seller to be insecure, at any time thereafter, Seller may declare all indebtedness secured hereby immediately due and payable and shall have all the rights and remedies of a Secured Party under the Uniform Commercial Code of Texas, including but in no way limited to the right to enter without legal process any premises where said merchandise is located and take possession thereof and remove same therefrom. Seller may thereafter sell, lease or otherwise dispose of any or all of the merchandise. Seller may remedy any default without waiving the default remedied or without waiving any prior or subsequent default. The undersigned agrees to pay any and all collection costs and reasonable and necessary attorney's fees in connection with Seller's pursuit of payment of any delinquent amounts.
12. Seller continually expedites orders and has influence with Manufacturer's delivery schedules but can be held in no way responsible for delayed deliveries. Orders once entered cannot be canceled due to delayed delivery unless manufacturer accepts cancellation from Seller.
13. This agreement shall be governed by and construed in accordance with the laws of the State of Texas; in the event of litigation or arbitration, venue shall lie in Houston, Harris County, Texas.
14. This contract, together with the application for credit, contains all of the terms, provisions, conditions and warranties of the purchase contract, and no extension, modification or amendment hereof shall be valid unless it is in writing signed by an officer of Seller.
15. All orders require a 50% deposit before any order is placed with the manufacturer.
16. Invoices are due and payable thirty (30) days after the invoice date, unless specified by special agreement.
17. By signature hereto, buyer acknowledges delivery and receipt of a true, correct, and complete copy of this contract including the application for credit incorporated here by references.
18. Time is of the essence of this agreement. These Terms and Conditions are subject to change without notice.
