



Therefore, the initiative is for this provision to be removed in order not to have a situation where the city, that is not elected by those people, cannot override the actions of the elected body and in return the legislation will provide that the County Assistance District would be dissolved upon the annexation and full service provision by the city. If the city annexes the area, that is covered by the CAD, the CAD will be dissolved so the City can collect sales tax and provide the services to people in the city paying the tax. This situation is matching accountability with responsibility.

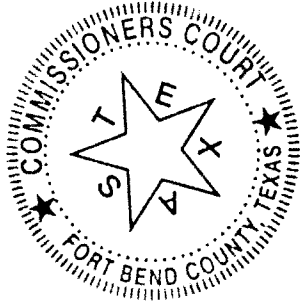
