**AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Aviles Engineering Corporation, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on July 10, 2018, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement for additional construction materials testing and inspection services to be provided and increase the total Maximum Compensation for such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional twenty-three thousand six hundred ninety-eight dollars and 25/100 (\$23,698.25) for the additional engineering services as described in Contractor's proposal dated December 3, 2018 attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed ninety-three thousand six hundred fifty-seven dollars and 10/100 (\$93,657.10), authorized as follows:
 - \$69,958.85 under the Agreement; and
 - \$23,698.25 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further written agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

Soils Inspection

Soils Inspection will be provided per the project specifications. Lime flyash 8" stabilized subgrade (10,728 yd²). Prior to stabilization of existing soils for paving subgrade, AEC will perform proofrolling inspection. Samples to determine the moisture density relationships (MDR) and other soil constants will be also obtained. AEC estimates sixteen (16) trips for inspection and testing.
