**FIRST AMENDMENT TO
 BUSINESS AGREEMENT BETWEEN NATIONAL SIGNS, LLC AND FORT BEND COUTNY**

This **FIRST AMENDMENT** of the **BUSINESS AGREEMENT BETWEEN NATIONAL SIGNS LLC AND FORT BEND COUNTY** is made and entered into by and between **FORT BEND COUNTY, TEXAS**, a body politic, acting herein by and through its Commissioners Court and **NATIONAL SIGNS, LLC** (hereinafter "**Contractor**"), a company authorized to conduct business in the State of Texas.

RECITALS

WHEREAS, on or about **MARCH 6, 2018**, the Parties entered into Addendum to Business Agreement Between National Signs, LLC and Fort Bend County, both incorporated by reference and referred to as "**the Agreement**"

WHEREAS, the Parties now desire to amend a certain portion of the Agreement; and

NOW THEREFORE, for and in consideration of the mutual benefits to be derived by the parties hereto, County, and Contractor agree as follows:

- I. **Amendment:** The Parties agree that an additional \$1,174.80 will be added to the total compensation, resulting in a not to exceed amount of \$112,174.80 for all Services performed. This additional funding shall be with regard to the expenses shown in Exhibit B.
- II. Except as modified herein, any prior executed document remain in full force and effect and has not been modified or amended. In the event of conflict, the contents of this First Amendment shall prevail.

III. Execution

IN TESTIMONY OF WHICH, THIS AMENDMENT shall be effective upon execution of all parties.

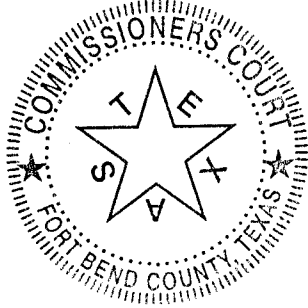
