**AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL CONSULTING SERVICES
 DRAINAGE STUDY OF MCCRARY ROAD, BRAZOSWOOD, AND WOODS EDGE AREA**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Freese and Nichols, Inc., (hereinafter "Consultant"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Consulting Services on May 22, 2018, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to all the Consultant to provide additional Services and increase the total Maximum Compensation under the Agreement for the completion of such additional Services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Consultant an additional twelve thousand three hundred ninety-four dollars and no/100 (\$12,394.00), for the additional Services as described in Consultant's Request for Authorization Amendment attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Consultant for Services rendered is hereby increased to an amount not to exceed one hundred fifty-nine thousand nine hundred ninety-four dollars and no/100 (\$159,994.00), authorized as follows:
 \$147,600.00 under the Agreement; and
 \$12,394.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
4. The Time of Performance under the Agreement is hereby extended to end no later than April 30, 2019.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the parties hereto have signed or have caused their respective names to be signed to be effective on the dated signed by the last party hereto.

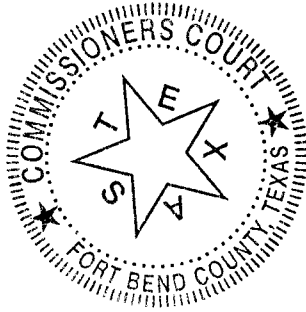

Freese and Nichols, Inc. (FNI) has been engaged in the drainage study for McCrary Road, Brazoswood, and Woods Edge areas. FNI requests additional funding to cover the costs for the effort associated with the evaluation and documentation of additional alternatives that were not included in the original scope of work, as directed by the County.

Additional alternatives include evaluation of the impacts from GCWA pumping operations on Jones Creek, additional channel sections and alignments for channel improvements, additional combination of individual alternatives, and developing cost estimates.

The total effort associated with these alternatives is \$12,394.
