**AMENDMENT NO. 5 TO WORK AUTHORIZATION NO. 2
 AGREEMENT FOR PLANNING, ENGINEERING, ENVIRONMENTAL ANALYSIS AND DESIGN SOQ
 14-027**

THIS FIFTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Lockwood, Andrews & Newnam, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Work Authorization No. 2 on November 3, 2015, and as amended on September 6, 2016, May 2, 2017, February 6, 2018 and on October 23, 2018 (hereinafter "WA No.2) and incorporated by reference herein for all purposes; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement to the same extent as if fully set forth verbatim therein:

NOW, THEREFORE, the parties do mutually agree as follows:

1. Work Authorization No. 2's Pay Schedule will be replaced with the REVISED BUDGET, attached hereto as ATTACHMENT A.
2. The maximum amount available to perform Services for Work Authorization No. 2 shall be increased by three hundred seventy-four thousand six hundred sixty-seven dollars and no/100 cents (**\$374,667.00**). bringing the new Total Maximum Compensation for Work Authorization No. 2 to one million six hundred seventy-four thousand four hundred twenty-nine dollars and no/cents (**\$1,674,429.00**). In no case shall the amount paid by the County for Services exceed the Maximum Compensation without prior written approval by both parties.
3. All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of Agreement. If there is a conflict between this Fifth Amendment to Work Authorization No. 2 and all earlier Amendments to WA No. 2 the provisions of this Fifth Amendment shall prevail with regard to the conflict.

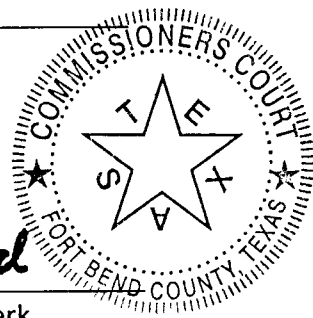




