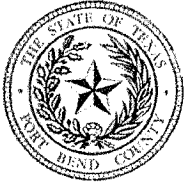

### Precinct 2

Sara Zhang is requesting a waiver of penalty, interest and collection fees for the 2017 tax year, stating that there was an error in failing to change the mailing address per their request. This resulted in not receiving the notice in a timely manner.

Tax Office records and research indicate:

- November 27, 2017 – 2017 Certified Statement mailed to: Aaronbrook Business Group, 13715 Murphy Rd. Ste. E Stafford TX, 77477-4900. **This statement was not returned by the Post Office.**
- December 26, 2017 – The Fort Bend County Central Appraisal District received a request to correct status, name or address on business personal property accounts stating the business was closed and listing the mailing address as 3622 Pinemont Dr., Houston, TX 77018.

- December 28, 2017 – The Tax Payer called the Tax Office to ask the amount due for 2017 and verified where and how the taxes could be paid.
- January 11, 2018 – Tax office received 2017 Supplement 3 from the Fort Bend County Appraisal District adding value change per 2525D penalty to be applied and changed the address to 3622 Pinemont Dr., Houston, TX 77018. Supplement statement was mailed to this address. **This statement was not returned by the Post Office.**
- February 26, 2018 – 2017 33.11 notice mailed by Linebarger, Goggan, Blair & Sampson, L.L.P. to Aaronbrook Business Group, 3622 Pinemont Dr., Houston, TX 77018. **This statement was returned from the Post Office.**
- March 8, 2018 – Tax office received 2017 Supplement 4 from the Fort Bend County Appraisal District changing the mailing address to 3622 Pinemont Dr., Houston, TX 77018. Supplement statement was mailed to this address. **This statement was not returned by the Post Office.**
- April 20, 2018 – Tax Office received a payment, check by phone through Linebarger, Goggan, Blair & Sampson, L.L.P. collected from the tax payer in the amount of \$14,993.12 including April penalty, interest and collection fees, which was later returned on May 7, 2018 due to “Unable To Locate Account”. The tax payer was mailed a letter giving additional time to resubmit another method of payment by May 23, 2018
- May 21, 2018 -- Tax Office received payment for the 2017 taxes including April penalty, interest and collection fees in the amount of \$14,993.12.
- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office
- Fort Bend WCID #2, HCC Stafford and Stafford MSD has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.
