**2. Workshop to receive presentation by Emergency Manager/Fire Marshal Mark Flathouse regarding office operations.**

Mark Flathouse, Emergency Manager/Fire Marshal gave a presentation on the short term and long term goals of the EOC/OEM. He indicated in the first 30 days as Emergency Manager, he evaluated the staffing and operations of the Office of Emergency Management. The next 30 days, he worked on the efficiency of the office. Going into the Hurricane season and the expectations from the Judge's office, he looked into what his needs are in moving forward. Mr. Flathouse has requested either building a new Emergency Operations facility, modifying the current facility or moving to another facility.

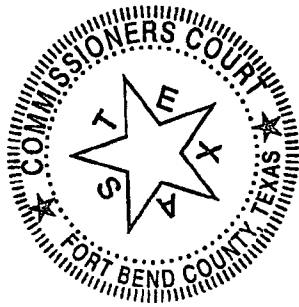
**3. Take action as necessary based on the workshop presentation.**
