

5. Public Comments regarding the Agenda and Announcements.

Service Awards were presented to County employees.

Commissioner Morales recognized Rene Vasquez, Director of Animal Services and Barbara Voss, Community Involvement Coordinator, Fort Bend County Animal Services. In 2017, Fort Bend Animal Services brought in a national organization, Best Friends, which did an assessment and suggested a 501(c)(3) be formed for their benefit. Commissioner Morales took on this task, with the help of a partnership with three individuals and Fort Bend Animal Services to form Fort Bend PAWS, which is a 501(c)(3). In February of 2019, \$15,000 was donated to Fort Bend Animal Services to cover, medical costs, spay and neuter, etc., the necessities needed to continue their efforts in becoming a no kill shelter. Recently, there have been some medical incidents, including one dog, Phoenix, and numerous spay and neuter for cats and dogs. Fort Bend PAWS reached out to the community, including online donations. Within less than a week, Fort Bend PAWS received over \$8,435 to be used strictly for spay and neuter and medical expenses occurring at Fort Bend Animal Services. Fort Bend PAWS is willing to match up to \$7,500. A check was presented for \$15,935 to Fort Bend Animal Services to help with what is needed to achieve without increasing the County Budget.

Michelle Turner, Chief General Counsel, stated in order to accept the check there must be a court action to accept and must be publicly noticed on the Agenda. (Item 31B is the court action to accept the donation.)

Judge George accepted the check for Fort Bend County Animal Services on behalf of the County.

Commissioner Meyers, introduced his summer intern Melissa Rodriguez.

Commissioner DeMerchant thanked Imam Ahmad Khan of the Maryam Islamic Center, for coming out and performing the Invocation.

Receive information by legislative consultants regarding the 86th Texas Legislative Session.

Mr. Jim Short, Legislative Consultant and Ms. Michelle Wittenburg, Governmental Affairs
Consultant & Attorney at Law gave an overview on the 86th Texas Legislative Session. Mr. Short
thanked the members of the court for their multiple trips to Austin and high degree of involvement,
more than he has seen in a number of years. Ms. Wittenburg gave an overview of the overriding
issues for the legislative session. She began by saying the Governor had five emergency issues on
his agenda, the Speaker had four primary agenda items and the Lieutenant Governor had 30.
There were three issues, called The Big Three, that were agreed on to pursue. They were the
Public School Finance Reform, Property Tax Reform, Senate Bill 2 and Hurricane and Disaster
Preparedness and Recovery. There was a second theme, which was a significant overriding theme
in this session, the Local Political Subdivision. In this session, there were more bills filed and
fewer passed.

**Below are some of the Bills Fort Bend County Commissioners Court passed unanimously
with resolutions and support.**

Property Tax Bill - The rollback rate was set at 3.5% for counties and cities, but there were carve
outs. These carve outs were to take parts of the general tax rate the County is not responsible for,
such as indigent health, indigent legal services, junior college fees, out of the part that would be
put in the calculation of the rollback rate. Effectively, when they are taken out, the roll back rate is
somewhat higher than 3.5%.

Secure the right to have meetings during emergencies without having the same posting rules as the rules for normal times. A bill did pass which provides in the most extreme cases the court can call a meeting of the court on an hour's notice and in slightly lesser extreme on two hour's notice. A suspension must be created of the open meetings act for seven days initially and can extend for another seven days. The County Judge must ask for the suspension specifically and must inform the Attorney General he is asking for the suspension. During the suspension all request for public information are on hold until the suspension period is over, whether it's one suspension or two.

Park Rules for County Parks - Attempted to secure the right for the County to make rules for the use of County Parks for safety and health regulation purposes. This bill did not pass.

Equal Pay Bill - There was no traction in the House or the Senate.

Creating a fund to help local governments acquire voting systems equipment. This bill did not pass. The monetary side may be dealt with next session because other counties may need or going to need new voter equipment.

Initiative to Create an Enterprise Zone - This bill did pass.

Good Samaritan liability for pets in hot cars - This bill did not pass.

County Assistance District Bill to dissolve a County Assistance District - This bill did pass.

Allowing a County Assistance District to make an expenditure outside its boundaries - There were two bills that passed; but was vetoed by the Governor. It did not have adequate protection to prevent abuse.

The ability to appoint Magistrates - The stand alone bill was not passed. The Chairman of the Committee who deals predominantly with Judiciary, have an omnibus court creation bill and Fort Bend County was included in that bill as having the authority to appoint magistrates.

Having the Authority to Use Drones especially during emergencies to inspect infrastructure - This bill did not pass.

The Emergency Warning System - The bill was passed and vetoed.

Jail Diversion and Mental Health - Our stand alone bill did not pass; but certain important features in the bill did pass.

License Court Interpreters - This bill was not in shape to move further along.

Cemeteries Bill - allows Counties to maintain cemeteries. This bill did pass.

Texas Heritage Parkway- This bill did pass.

Mr. Short stated the County had a long program this year with 40 bills he was trying to pass and countless others he was trying to keep from passing.

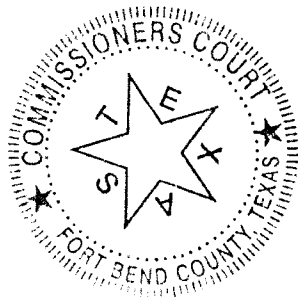
