Any revision of the bond amount shall not be cumulative.

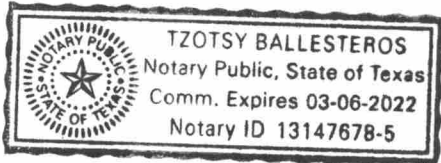

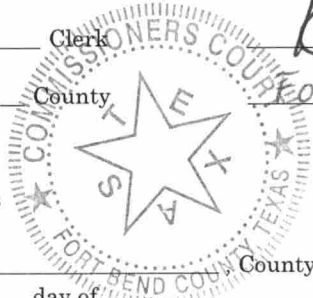

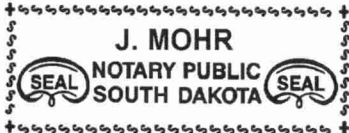

Texas Transportation Code
§ 252.104
Bond of Road Commissioner

- (a) Before assuming the duties of a road commissioner, a road commissioner must execute a bond with one or more good and sufficient sureties payable to the county judge in the amount of \$1,000, conditioned on the faithful performance of the road commissioners duties.
- (b) To be effective, the bond must be approved by the county judge.
