RE: Release multiple Perpetual and Performance bonds as listed

Dear Judge & Commissioners:

Two years ago the County Clerk's office began turning over all recorded original Perpetual and Performance bonds to Engineering for recordkeeping. A list of all the outstanding Perpetual and Performance bonds that were in their file cabinet was generated. The originals were transferred to Engineering on 2/20/2019. After sorting them out the ones that remained on the list and are to be released by Commissioner Court according to the list provided.

Over the years the procedure was for the contractor to request a release of his bond once the permitted project was complete. Many failed to do so. The projects are either built or the original permits are void because construction did not start within one year of the permit being issued. Therefore, they were never released resulting in this enormous list.

Due to REDACTION, the bond numbers can not appear on the list. Therefore, an interdepartmental list and scanned PDF of the bonds will be kept within the Permitting files. Once the bonds are approved for release by Commissioners Court, we will maintain our interdepartmental files of the list and bonds to fulfill the records management requirements for Fort Bend County.
