**SECOND AMENDMENT TO AGREEMENT FOR  
 PROFESSIONAL ENGINEERING SERVICES**

**THIS SECOND AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Associated Testing Laboratories, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on July 24, 2018, (hereinafter "Agreement") pursuant to SOQ 14-025, as amended by document executed on April 2, 2019, (hereinafter the "Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional sixteen thousand one hundred thirty-four dollars and no/100 (\$16,134.00), for the services as described in Contractor's Request for Budget Increase dated August 1, 2019, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed one hundred twenty-three thousand five hundred twelve dollars and 88/100 (\$123,512.88), authorized as follows:
  - \$77,000.00 under the Agreement;
  - \$30,378.88 under the Amendment; and
  - \$16,134.00 under this Second Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and any subsequently executed amendment exceed the Maximum Compensation without further written agreement executed by both parties.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.

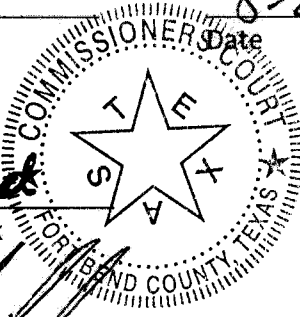

Reference: Request for Budget Increase for the A Myers Road Project

- 1- Based on the additional information provided regarding the murky material stabilization design (not in the original contract or part of the last budget extension dated March 6, 2019), expected area of stabilization (Trapezoidal shaped occupying an area of approximately 13,600 sq. ft, which was more than what was anticipated initially), and our experience with similar projects, we request an increase in the budget as stated below:

Senior Field Technician	110	Hours	75	8,250.00
Vehicle Charge	90	Hours	10	900.00
Grout/Concrete Testing*	20	Each	6**	120.00
Project Engineer P.E.	10	Hours	149	1,490.00

\*Note that Grout testing is more expensive than the regular cylinders

\*\* Showing only the increase in cost from cylinders to Grout Testing, i.e., from \$17 to \$23

- 2- The above cost does not include the 12 hours of Senior Engineer's time (site visit and engineering recommendations for stabilizing the murky material). That cost including the vehicle charge will be an additional amount of \$2,286.00.
- 3- Additional test on the cores taken from asphalt layers at the A Myers Road Project. The cost of testing of these cores were not a part of original scope of work (See our request of budget increase of \$3,088.00 dated April 24, 2019)

ATL respectfully asks that you consider the above additional work to increase ATL's testing budget by \$16,134.00.

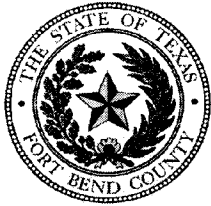
