**RENEWAL TO REVOCABLE LICENSE AGREEMENT BETWEEN
KATY UNITED, LLC AND FORT BEND COUNTY
FOR USE OF BALL FIELDS AT FREEDOM PARK FY 2020**

THIS RENEWAL is entered into by and between Fort Bend County ("County"), a body corporate and politic under the laws of the State of Texas, and Katy United LLC, DBA: Katy United ("Katy United"), a Texas non-profit corporation.

WITNESSETH


WHEREAS, the parties have previously executed a revocable license agreement on or about October 2, 2018 for a one (1) year term (the "Agreement,") incorporated herein by reference;

WHEREAS, County and Katy United now desire to renew the Agreement for an additional one year term;

NOW, THEREFORE, in consideration of the foregoing, the Agreement between the County and Katy United is hereby amended as follows:

1. The Agreement is renewed for an additional one (1) year term beginning October 1, 2019 and ending on September 30, 2020.
2. Katy United shall ensure that the "Waiver and Release of Liability for Use of Fort Bend County Freedom Park Facilities" attached to this Renewal as "Exhibit A" shall continue to be executed by each League Participant prior to participation.
3. Except as modified herein, the terms of the Agreement shall remain in full force and effect. If there is a conflict between this Renewal and the License Agreement, the provisions of this Renewal shall prevail. This Renewal shall be effective upon execution by the County.



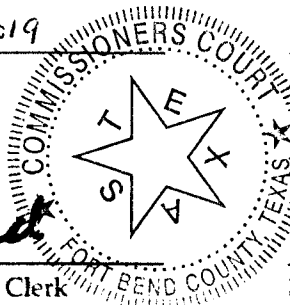
