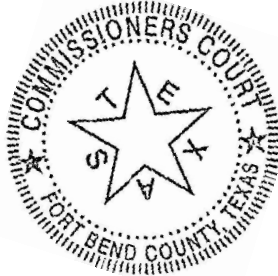
Jaime Kovar, Purchasing Agent stated the old bulldozer is not being used and will be traded in for a new smaller one.
