

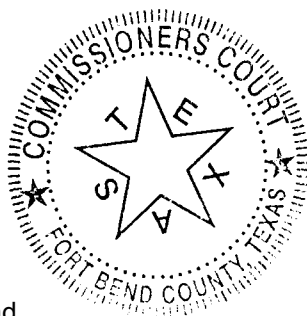

### **NIJ Body Armor Standards**

Applicant assures that body armor purchased with grant funds will comply with the National Institute of Justice (NIJ) standard (Ballistic Resistance of Body Armor NIJ Standard-0101.06) for type III (rifles) or type IV (armor piercing rifle) body armor, including bullet-resistant vests, ballistic plates, and plate carriers.

### **Personally Fitted Vest Requirement**

Applicant assures that all body armor vests purchased with grant funds will be personally fitted for individual officers, including vests specifically fitted to individual female law enforcement officers. "Personally fitted" does not require armor be individually manufactured based on the measurements of a specific wearer, but rather that it provide the best possible fit and coverage, through a combination of:

1. Correctly-sized panels and carrier, determined through appropriate measurement; and
2. Properly adjusted straps, harnesses, fasteners, flaps, or other adjustable features.

The American Society for Testing and Materials (ASTM) International has made available the Standard Practice for Body Armor Wearer Measurement and Fitting of Armor ([Active Standard ASTM E3003](#)) available at no cost. The Personal Armor Fit Assessment [checklist](#), is excerpted from ASTM E3003.

### **Criminal History Reporting**

Entities receiving funds from PSO must be located in a county that has an average of 90% or above on both adult and juvenile dispositions entered into the computerized criminal history database maintained by the Texas Department of Public Safety (DPS) as directed in the *Texas Code of Criminal Procedure, Chapter 66*. The disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the computerized criminal history system.

Beginning January 1, 2020, counties applying for grant awards from the Office of the Governor must commit that the county will report at least 90 percent of convictions within seven business days to the Criminal Justice Information System at the Department of Public Safety. ### **Uniform Crime Reporting (UCR)**

Eligible applicants operating a law enforcement agency must be current on reporting Part I violent crime data to the Texas Department of Public Safety (DPS) for inclusion in the annual Uniform Crime Report (UCR). To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year.

### **Conversion to National Incident-Based Reporting System (NIBRS)**

The Texas Department of Public Safety (DPS) has established a goal set by the Texas Legislature for all local law enforcement agencies to implement and report crime statistics data by using the requirements of the National Incident-Based Reporting System (NIBRS). Additionally, the Federal Bureau of Investigation (FBI) will collect required crime statistics solely through the NIBRS starting January 1, 2021. Due to this federal deadline, grantees are advised that eligibility for future grant funding may be tied to compliance with NIBRS. Financial grant assistance for transitioning to NIBRS may be available for your jurisdiction from the Public Safety Office.

### **Project Abstract :**

The Fort Bend County Constables' Offices provide traffic and highway patrol, tactical response, warrant-serves, investigation, management and administration, among other duties. All law enforcement personnel, regardless of rank or job function, face a growing and potential threat to become the target of an attack or act of violence against them while they are in uniform or in a marked vehicle. Fort Bend County is one of the fastest-growing counties in the nation, and it is projected to reach a population of 1,000,000 residents by 2022 (Nezral Haque, University of Houston Hobby School of Public Affairs, May 2017). While some deputies are currently equipped with body armor, this rifle-resistant body armor will enhance all officer's capacity to prevent, protect against, and respond to assaultive acts involving high-caliber weaponry.

### **Problem Statement :**

Fort Bend County has rapidly grown and shifted the county's status from rural to nearly 95% urban in 2018 (U.S. Census Bureau). The majority of the population growth has occurred in the unincorporated areas, whose residents rely solely on the County for essential services such as law enforcement. Approximately two out of three residents reside in an unincorporated part of Fort Bend County, which has stretched Fort Bend County law enforcement agencies' resources thin. Fort Bend County shares its eastern border with Harris County, and the City of Houston's jurisdiction overlaps with eastern Fort Bend County. The violent crime prevalent in dense urban areas like Houston has begun to permeate Fort Bend County's suburban communities, and law enforcement has experienced an increase in drug arrests, drug-related crimes, and gang-related crimes. Further, the ability for criminals to easily obtain high-powered weaponry has put law enforcement at additional risk. In July 2017, an assailant armed with a rifle fired shots into the crowded Sugar Land Town Center area. In 2019, a man previously arrested by Fort Bend County law enforcement was arrested for murdering a police officer in neighboring Harris County.

**Supporting Data :**

Fort Bend County has been one of the fastest-growing counties in the nation for nearly a decade, with an estimated population of 787,858 (U.S. Census Bureau, July 1, 2018). It's growth remains rapid, and the University of Houston Hobby School of Public Affairs estimates that if current trends continue, it will be home to more than one million people by 2022. The majority of the growth has occurred in the unincorporated areas of Fort Bend County, especially in Precinct One and Precinct Three(Texas Association of Counties). Acts of violence against Fort Bend County law enforcement officers remains a constant threat, and law enforcement officers regardless of rank or job function, whether they are pursuing a high-speed chase or serving an eviction notice, must be able to protect themselves from any and all threat that arises.
