**SECOND AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENVIRONMENTAL SERVICES**

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and BIO-West, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Environmental Services on March 27, 2018 pursuant to SOQ 14-025, (hereinafter "Agreement"), as amended by document executed on September 4, 2018, (hereinafter "Amendment"); and

WHEREAS, the parties desire to further amend the Agreement to allow Contractor to provide additional Services under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional amount not to exceed nine thousand dollars and no/100 (\$9,000.00) to perform the additional Services, as described in Contractor's proposal dated March 24, 2020 attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed one hundred sixty-seven thousand five hundred dollars and no/100 (\$167,500.00), authorized as follows:
 - \$150,500.00 under the Agreement
 - \$8,000.00 under the Amendment; and
 - \$9,000.00 under this Second Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Second Amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.



BIO-WEST, Inc. (BIO-WEST) is pleased to provide the Fort Bend County Engineering Office (FBC-ENG) this additional proposal and cost estimate to provide the requested environmental services for the Loop FM 762 – Front Street roadway project, part of the 2017 Fort Bend County Mobility Projects. BIO-WEST is currently under contract to provide environmental services for multiple other road projects under the 2017 Fort Bend County Mobility Projects, the PO for those projects is 164490 and a copy of that PO is attached to this Scope of Work and Cost Estimate.

PROJECT APPROACH

Environmental Review

BIO-WEST will provide environmental support for the Loop FM 762 and Front Street road project, based on comments made and information requested by Texas Department of Transportation (TXDOT). This specifically is in reference to environmental compliance with the Clean Water Act (CWA), Section 106 of the National Historic Preservation Act (NHPA), and the Endangered Species Act (ESA).

BIO-WEST ecologists will perform cursory field investigations for potential waters of the U.S., including a walk-through of the proposed project alignment, threatened and endangered species field investigations, and a basic desktop cultural resources analysis.

Based on project alignment review, it is BIO-WEST's opinion that no coordination with the United States Army Corps of Engineers or the United States Fish and Wildlife Service will be required. It is possible that coordination with the Texas Historical Commission (THC) will be required, due to the properties and agencies involved in the project.

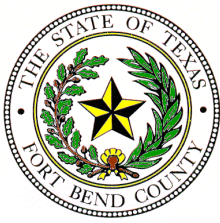
