**CORRECTION DECLARATION OF LOCAL DISASTER FOR
PUBLIC HEALTH EMERGENCY**

WHEREAS, beginning in December 2019, a novel coronavirus, now designated COVID-19, was detected in Wuhan City, Hubei Province, China, and has since spread throughout the world;

WHEREAS, the spread of COVID-19 has caused illness and death within Fort Bend County;

WHEREAS, after months of community spread, increase in rates of positive results from tests, more symptomatic cases, additional measures must be taken to contain COVID-19 and prevent its spread throughout Fort Bend County;

WHEREAS, on June 23, 2020, in a document incorrectly titled DECLARATION OF LOCAL DISASTER FOR PUBLIC HEALTH EMERGENCY, filed and recorded in the Official Public Records of Fort Bend County, Texas under Instrument Number 2020074865, attached hereto as Exhibit A and incorporated herein, I proclaimed:

1. That a local state of disaster for public health emergency is hereby declared for Fort Bend County, pursuant to section 418.108(a) of the Texas Government Code.
2. Pursuant to section 418.108(b) of the Government Code, the state of disaster for public health emergency shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the Commissioners Court of Fort Bend County, Texas.
3. Pursuant to section 418.108(c) of the Government Code, this declaration of a local state of disaster for public health emergency shall be given prompt and general publicity and shall be filed promptly with the County Clerk
4. Pursuant to section 418.108 (d) of the Government Code, this declaration of a local state of disaster activates the Fort Bend County emergency management plan.
5. Any individual, group of individuals, or property subject to a Local Health Authority Order restricting the movement of that individual or group of individuals or restricting movement to, from, or within that property, shall limit ingress and egress and take such measures as specified by that Local Health Authority Order.
6. That this declaration shall take effect immediately from and after its issuance; and

WHEREAS, a correction is necessary to reflect the correct spelling of “**DISASTER**” in such Declaration of Local Public Disaster for Public Health Emergency; and

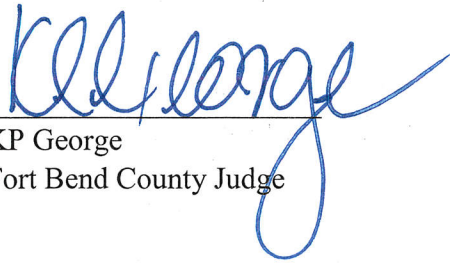
NOW, THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE OF FORT BEND COUNTY, TEXAS:

This Correction Declaration of Local Public Disaster for Public Health Emergency is given for the purpose of acknowledging and correcting the misspelling of “**DISASTER**” in the Declaration of Local Public Disaster for Public Health Emergency dated, filed and recorded on

June 23, 2020 under Instrument Number 2020074865 of the Official Public Records of Fort Bend County, Texas.

This Correction Declaration of Local Public Disaster for Public Health Emergency amends and restates the Declaration of Local Public Disaster for Public Health Emergency in its entirety, and the provisions contained in this Correction Declaration of Local Public Disaster for Public Health Emergency supersede and replace all provisions to the contrary in the Declaration of Local Public Disaster for Public Health Emergency.

DECLARED this the 26th day of June, 2020, *to be effective for all purposes as of June 23, 2020.*

DECLARATION OF LOCAL DISASSTER FOR

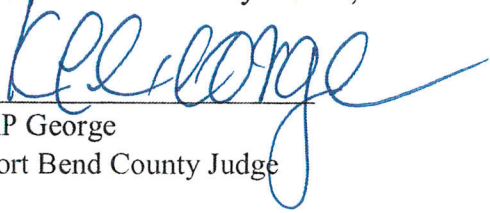
WHEREAS, the spread of COVID-19 has caused illness and death within Fort Bend County; and

WHEREAS, after months of community spread, increase in rates of positive results from test, more symptomatic cases, additional measures must be taken to contain COVID-19 and prevent its spread throughout Fort Bend County.

NOW, THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE OF FORT BEND COUNTY, TEXAS:

1. That a local state of disaster for public health emergency is hereby declared for Fort Bend County, pursuant to section 418.108(a) of the Texas Government Code.
2. Pursuant to section 418.108(b) of the Government Code, the state of disaster for public health emergency shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the Commissioners Court of Fort Bend County, Texas.
3. Pursuant to section 418.108(c) of the Government Code, this declaration of a local state of disaster for public health emergency shall be given prompt and general publicity and shall be filed promptly with the County Clerk
4. Pursuant to section 418.108 (d) of the Government Code, this declaration of a local state of disaster activates the Fort Bend County emergency management plan.
5. Any individual, group of individuals, or property subject to a Local Health Authority Order restricting the movement of that individual or group of individuals or restricting movement to, from, or within that property, shall limit ingress and egress and take such measures as specified by that Local Health Authority Order.
6. That this declaration shall take effect immediately from and after its issuance.
