**AMENDMENT TO AGREEMENT BETWEEN FORT BEND COUNTY AND KONE, INC.
 FOR ELEVATOR MODERNIZATION AND MAINTENANCE SERVICES**
(Utilizing US Communities Kone Cooperative Contract No. EV2516)

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Kone, Inc., (hereinafter “Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Elevator Modernization and Maintenance Services on or about June 2, 2020, (hereinafter “Agreement”); and

WHEREAS, the parties desire to amend the Agreement to add services to be provided at the Missouri City Branch Library and increase the total Maximum Compensation payable for the completion of such services provided thereunder.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional two thousand six hundred twenty-five and 00/100 (\$2,625.00) for elevator services for the new elevator located at the Missouri City Branch Library as reflected in the Contractor’s proposal amended 8/2020, attached hereto as Exhibit “A” and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed one hundred fifty-one thousand six hundred fifty and 00/100 dollars (\$151,650.00), authorized as follows:
 - \$2,625.00 under the Agreement; and
 - \$151,650.00 total compensation under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
