4. Public Comments regarding the Agenda and Announcements.

A proclamation was presented to Owen Kaminski and Kaila Fiallos, who participated in the 4-H Youth Development Program of the Texas A&M AgriLife Extension Service. Angela Romans, County Extension Agent - 4H & Youth accompanied the participants. Commissioners Court declared the week of October 4 - 10, 2020 as National 4-H Week in Fort Bend County, Texas.

October is National Cyber Security Awareness month. Judge George thanked the Information Technology Department who has been sending information on how to protect ourselves and our network.

Judge George expressed condolences to the County Attorney, Honorable Roy Cordes on the passing of Helen Cordes.

Judge George asked to keep in thoughts and prayers, President Donald Trump, his family and numerous federal government leaders who are currently battling COVID-19.

Fort Bend County is currently seeing a positive impact during the pandemic by our proactive actions, such as wearing masks and social distancing during all mass gatherings. In coordination with Fort Bend Health and Human Services, Judge George announced the County is lowering the risk level to yellow, which is low or moderate risk category. While the signs look good, holidays are around the corner, teachers and students are going back to in person learning and nursing homes have relaxed the visitation rules, this is not the time to let our guard down. Dr. Jacquelyn Minter, Director of Health & Human Services gave an update on Coronavirus in Fort Bend County. Dr. Minter stated the County has seen an improvement when comparing where the County was in July. There was a great decrease in cases in August. In the last few weeks the County has seen a moderate uptick; but is not approaching where the County was in the past. The hospitals are seeing a lot less of the number of COVID positive patients in the general wards and ICU and are well under 10%, averaging around 5%. Dr. Minter is expecting there will be another wave and recommends everyone continue to wear masks, physical distance and assess their own risk.

Mark Flathouse, Emergency Manager/Fire Marshal, gave an update on the current storms. Currently, in the Gulf, there is a hurricane, level 4, with 135 mph winds headed our way. On Thursday, the storm may take a northern route and the County will be on the west side of the cone. Mr. Flathouse will keep Commissioners Court up to date and there are no advisories at this time. The storm has a potential to make landfall on Friday morning into Friday afternoon.

Judge George thanked those who gave generous donations to the Adopt-a-Family Program, Agenda Item 6B.

The increase of \$7 million will allow the opportunity to help businesses who did not get a second opportunity from the federal government.
