**AMENDMENT NO. 5 TO WORK AUTHORIZATION NO. 3 & NO. 4  
 TO PROFESSIONAL SERVICE AGREEMENT FOR PARK AND RIDE FACILITY PLANNING  
 AND CONSULTING SERVICES

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and IDCUS, (formerly known as IDC, Inc., hereinafter "Engineer" or "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Professional Engineering Services Agreement on January 26, 2010 (hereinafter "Agreement") for preliminary planning activities for park and ride facilities located in Fort Bend County, Texas; and

WHEREAS, the parties executed Work Authorization No. 3 and Work Authorization No. 4 on or about September 24, 2013, and as amended on or about March 25, 2014, November 24, 2014, November 28, 2017, and March 20, 2018 incorporated herein by reference; and attached as Exhibit A; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. The time for performance of Services shall be extended for additional period of time ending on May 31, 2022, unless extended by further agreement of the parties.
2. Human Trafficking. BY ACCEPTANCE OF CONTRACT, CONTRACTOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of the Agreement. If there is a conflict between this Fifth Amendment and the Agreement for Professional Services, the provisions of this Fifth Amendment shall prevail with regard to the conflict.

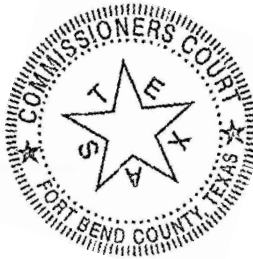
