**RENEWAL TO LICENSE AGREEMENT FOR USE OF BALL FIELDS AT HARLEM ROAD
 PARK BETWEEN LAMAR LITTLE LEAGUE, INC. AND FORT BEND COUNTY**

THIS RENEWAL is entered into by and between Fort Bend County ("County"), a body corporate and politic under the laws of the State of Texas, and Lamar Little League, Inc. ("Lamar Little League"), a company authorized to do business in the State of Texas.

WITNESSETH

WHEREAS, the parties have previously executed a revocable license agreement on or about November 5, 2019, for a one (1) year term (the "Agreement") incorporated herein by reference;

WHEREAS, County and Lamar Little League now desire to renew the Agreement for an additional one year term;

NOW, THEREFORE, in consideration of the foregoing, the Agreement between the County and Lamar Little League is hereby amended as follows:

1. The Agreement shall be renewed for an additional one (1) year term beginning October 1, 2020 and ending on September 30, 2021.
2. Lamar Little League shall ensure that each Lamar Little League participant signs a "Fort Bend County Park Facilities Acknowledgement of Risk, Release and Waiver of Liability Agreement" attached to this Renewal as "Exhibit A" prior to participation. All signed copies must be maintained by Lamar Little League and released to County upon request.
3. Except as modified herein, the terms of the Agreement shall remain in full force and effect. If there is a conflict between this Renewal and the License Agreement, the provisions of this Renewal shall prevail. This Renewal shall be effective upon execution by the County.
