4. Public Comments regarding the Agenda and Announcements.

No public comments.

Judge George recognized and thanked County Officials who provided services for years to Fort Bend County. Congressman Elect Troy Nehls, District 22, County Attorney Roy Cordes, Constable Trevor Nehls, Constable Wayne Thompson, Judge Brenda Mullinix, Judge Jim Shoemake, Judge David Perwin and Judge Maggie Jaramillo. Judge George is looking forward to working with all new and returning County Officials.

Dr. Jacquelyn Minter, Health & Human Services Director gave an update on the current status of COVID-19 in Fort Bend County. There are approximately 27,000 confirmed cases of COVID-19, since March 4, when the first case was reported in Fort Bend County. Of those cases almost 23,000 have recovered. Today, there are 331 people who have passed away from this disease. There have been over 90,000 test taken at the Fort Bend County sites. The number of cases have increased in the first 10 days of December and November over the prior two months. Hospitals are greater than 15% with COVID patients. One of the highlights is that a vaccine is rolling out. This is the beginning of being COVID free and will improve the COVID status. MD Anderson in the Texas Medical Center has received the first doses in the area and the rest of the medical center should receive the vaccine today. The 22 hospitals that are slotted to get the vaccine will receive those by the remainder of this week. Methodist will get their vaccines sometime this week and will begin with Phase I allocation by vaccinating Healthcare workers and hospital workers, who are in direct contact with COVID patients. Next, will be the critical group who are essential workers, including, first responders, educators and others who will come in contact with the disease. After the essential workers, the next group are the high risk people with severe outcomes, and then those who may be at risk and may traditionally not get vaccines. In the next coming months everyone will have the opportunity to get the vaccine as more become available. The HHS department is working with schools that continue to have outbreaks and are working to get more providers educated and onboard ready to receive vaccines or to vaccinate the residents of Fort Bend County. HHS is also getting good information out to make sure everyone knows about the risk and the benefits of the vaccine.

Commissioner Meyers wished everyone a Merry Christmas and a Happy New Year.

Commissioner DeMerchant updated everyone regarding the small business grant opportunities. The portal is being reopened to apply later this week. Commissioner Meyers asked the County Auditor to explain where the County is in the process of the funds being allocated.

Ed Sturdivant, County Auditor stated with the allocation made by Commissioners Court, last week, for the small business program, in which of note, the application portal opens tomorrow morning at 8 a.m.

At 1:25 p.m. the County Auditor had technical difficulties. Commissioners Court tabled this Item and moved to Items 24 and 25.

At 1:27 p.m. the Court returned to this item to continue the discussion with the County Auditor.

Ed Sturdivant, County Auditor explained the current situation. If the court were to allocate an additional amount of \$2 million for this initiative, the County would still have an additional \$2 million to address other needs. The court can expect Mr. Sturdivant to come back at the end of January to address a reprioritization and reallocation. Mr. Sturdivant stated the County has spent \$30 million to date and there is \$47.5 million total allocated to small businesses. As presented last week, there is \$6.5 - \$12 million available to address needs. With opening the program tomorrow morning for small business, with the remaining balance of \$17.5 million, Mr. Sturdivant believes the needs can be fulfilled for all the businesses who will apply for the program. Included is the ability of the court to allocate an additional \$4 million for other initiatives. This is being presented because this is what the County currently has as an option based on the assessment as of today in available funds to redirect for other purposes. The County has until the end of March to expend the last dollar from CARES for expenditures incurred through the end of December. Applicants can apply after January 31 as long as the expenditures they are using the grant for were used before the month of January.

Commissioner Meyers stated the County has a small business program and has allocated some \$30 million. Are there enough funds remaining to cover any contingency that may come up.

Commissioner Morales asked Commissioner DeMerchant if the \$2 million being allocated is a duplication of the County's program or something different to help small businesses.

Commissioner DeMerchant stated the \$2 million is for Sugar Land to develop programs. The City of Sugar Land will go through the County Auditor to get approval to get reimbursed. This money is from the CARES Act Fund and is not administered by the County.

Mr. Sturdivant indicated the allocation made to all of the cities was \$55 per capita. The only city that has received an additional allocation was Missouri City, which was used to enhance the small business and rent/mortgage/utility program in the City of Missouri City. Missouri City has committed about 10% of those funds, in which, MPACT, the County's Strategic Consultant, indicated there is a lower demand for the additional allocation in Missouri City. Mr. Sturdivant stated most of the cities used the funds for PPE, improvements in their facility to promote social distancing and promote healthy environments for their employees. The businesses did not try to duplicate the County's testing and contact tracing effort. They left it up to the County's HHS department. The City of Sugar Land used their \$6.5 million to cover payroll for their public safety officers.

Commissioner Meyers asked why the City of Sugar Land is administering their own small business program in a very short time period, when the County has one in place. Also, could they refer the small businesses they identify to the County Auditor's office.

Item 22 continued - Commissioner, Pct. 4:

Commissioner DeMerchant stated he pushed to get the round three program opened for small businesses. Sugar Land is offering to roll out these programs for small businesses in their city and believes this will help the County. Commissioner stated this will be more efficient with more people implementing more programs.

Commissioner Morales asked what kind of program the City of Sugar Land has in place that they are expanding on.

Ed Sturdivant stated the City of Sugar Land has proposed proactive programs to move forward to improve social distancing in businesses as they recover. These are new initiatives that are somewhat different from where the County focused. The County's program covers expenditures that they incur in about eight different categories. Sugar Land seems to be targeting more specific results as far as recovery and is eligible under the CARES Act. If the City of Sugar Land is targeting one or several specific areas to support the businesses, they are not duplicating what the County is doing. The County did not target those initiatives and were broader within the eligibility criteria of CARES. Mr. Sturdivant will be bringing forth all of the budgets that still have balances in order for the court to make the best decision for the County as a whole to reprioritize and reallocate all available CARES funds that are currently under-utilized at the end of January.
