4. Public Comments regarding the Agenda and Announcements.

Judge George thanked and expressed his appreciation to the staff of Health & Human Services, IT, Access Health, the Sheriff's Deputies and everyone in between who worked to organize the distribution of the COVID-19 vaccinations for Fort Bend County citizens.

Dr. Jacquelyn Minter gave an update on the COVID vaccination. As of yesterday, there were over 4,600 vaccines administered, including a portion of the Moderna and a larger portion of the Pfizer vaccine. The vaccines are being administered at one location in Fort Bend County and HHS is making sure the County is at 1,000 doses a day. Currently, Dr. Minter is working on preregistered residents. She is appreciative to the court's support in reaching out in order to have agreements with other locations for residents to have the best opportunity to get vaccines, which is limited throughout the country. In the coming days an additional site will be opened and other sites are on the horizon. As soon as other sites are available, she will let the public know. There are second doses people will be getting. Emails will be going out to schedule with online scheduling soon.

Judge George encouraged citizens to try getting the vaccine at a hospital level or pharmacy that is administering the COVID vaccine.

Judge also reminded everyone this is Human Trafficking Prevention/Awareness month. The Judge's office has launched a Human Trafficking 101 Campaign to educate everyone about the dangers of Human Trafficking and ways to keep our children safe.

There were four public comments.

Bonnie Anderson, Precinct 3 spoke against Item 33B, the \$23 million rental program. Ms. Anderson stated this amount would be to pay rent for 3,875 families for six months. She also stated that those who need rental assistance due to job loss are not COVID related job loss; but lockdown related job loss. Ms. Anderson indicated decisions are being made based on the PCR test, in which research has determined these test create false/positives.

Vishalaxi Magdum, 5018 Tramonte Trail is against Items 23, 27E, 33B, 43A, E, E, F, G, H, P. Ms. Magdum has concerns on how funds received for the program will be used. She believes a portion of the funds could be used to help businesses that have closed down to open up again and hire their employees back and create more jobs. Ms. Magdum stated decisions have been made based on the number of positive cases by using the PCR test. This test gave high numbers of false/positive results and led to restrictions on the general public, like mask wearing. She requested the Commissioners reconsider spending FEMA funds and CARES Act funding on labs and stopping the PCR testing until the auditing of the test results are completed. Ms. Magdum also asked to reverse the mask mandate and not spend money on hiring more staff for the vaccination program.

Diane Weesner, 1507 Honeysuckly Lane expressed her concerns about Fort Bend County taking action on the agreements listed for Item 43P, to provide temporary staff and equipment for COVID-19 response activities related to vaccines throughout the County. Ms. Weesner asked if it was in the best interest of Fort Bend County residents for County Officials to engage at this time in the continued distribution of COVID-19 vaccines and encourage Fort Bend County residents to receive these experimental vaccines.

Item 4 continued - Public Comments:

Surekha Patil, 1020 Brand Lane, Stafford spoke on Items 33B and 43H, the rental program. Ms. Patil asked the court to use these funds to support small businesses that have been hurt and shut down. This would create more jobs which she believes is a permanent solution, instead of a temporary solution of giving rental funds for 6 months. She also agrees that the PCR test gives false/positive results. Ms. Patil asked about the COVID-19 Response Operation that is mentioned in Item 43H. She also asked about the need for renters space when hospitals are not overwhelming and asked if the space will be used for vaccinations or testing.

Ed Sturdivant, County Auditor explained the Department of Treasury, with the most recent bill passed by Congress, allocated funds for the Emergency Rental Assistance Program going beyond December 2020. Because Fort Bend County has a population greater than 200,000 and the only other public entity in the County that has a population of this amount or greater is the City of Houston, the allocation based on population resulted in a direct payment to Fort Bend County of \$23.249 million with a specific eligible use of rental and utilities only for individuals and families that were first affected or impacted by the pandemic, meaning loss of income, and that their income pre-pandemic met the 80% of the lower/moderate income level or lower. This is a very specific target group for this funding. The Congress carved out mortgages as an eligible use for these funds.

Judge George stated the mortgage is not covered.

Commissioner Meyers asked if funds were available for the small businesses assistance program.

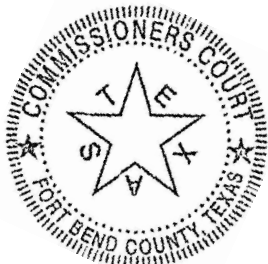
