4. Public Comments regarding the Agenda and Announcements.

Dr. Jacquelyn Minter, Director of Health & Human Services gave an update on the new order from Governor Abbott and the progression of the vaccine activity in Fort Bend County. As of yesterday, March 8, almost 52,000 laboratory confirmed cases of COVID-19 have been posted in Fort Bend County, with over 49,000 recoveries. The average daily growth rate has declined from a peak of over 400 daily in December and January to an average of about 200 daily. The test positivity is at double digits after a few weeks being under 10% in Fort Bend County. This could be a factor from the winter storm and sharing of close quarters by multiple households. This trend has been seen throughout the Houston area. Hospitals and providers have witnessed those who have suffered and recovered from COVID-19 during the Spring and Summer and became infected again in the Winter and succumbed to this disease. Due to these situations, the push for the vaccination is even more important. As of March 6, there have been over 75,000 first and second doses of the vaccine administered at Fort Bend County sites. According to the Department of State Health Services, along with providers throughout the area, over 230,000 Fort Bend County residents have been vaccinated by all providers. Now teachers, education workers, childcare workers are included in the priority groups. Effective tomorrow, March 10, the mask mandate for the state will be rescinded. Dr. Minter reminded residents all vaccination sites will require face coverings in order to be vaccinated. This is to provide the safety and health of employees and the public in these healthcare settings. Masks will be provided to those who do not have them and the drive through vaccination clinics are offered as an alternative. The CDC has offered some new recommendations for those who are fully vaccinated. As a reminder, people are not fully vaccinated the minute one gets their vaccine. It requires two weeks after the second dose of a two dose series or two weeks after the first dose of a one dose series in order for the immune system to fully protect a person. According to the CDC, fully vaccinated people need to still take precautions in public by wearing a well fitted mask, by physical distancing and adhering to other prevention measures, especially when around those who are unvaccinated and are at increased risk for severe COVID disease. Citizens should continue to avoid medium and large size gatherings, because the majority of the population is not vaccinated. As great as these vaccines are, they are not perfect and not 100% protected. There are some people who may get vaccinated and still get COVID.

Judge George stated even through these struggles, there are unofficial numbers showing Fort Bend County's population is staying at 859,000, which has surpassed El Paso County. Fort Bend County is No. 9 in the state of Texas, which is encouraging. Even during COVID, the County was able to grow and the residential market is strong in Fort Bend County.
