3. This permit expires one (1) year from date of permit if construction has not commenced.
4. This permit applies to work performed within right-of-ways owned and maintained by Fort Bend County only, and it is the responsibility of the applicant to acquire all other necessary permits and permissions.



KNOW ALL MEN BY THESE PRESENTS:

THAT WE, McKinney Construction, Inc. whose (address, phone) is 1955 W. McKinney St. Houston Texas 77019 / (281)924-0393, hereinafter called the Principal, and SureTec Insurance Company, a Corporation existing under and by virtue of the laws of the state of Texas and authorized to do an indemnifying business in the state of Texas, and whose principal office is located at (name/address/phone) 2103 CityWest Blvd., Ste. 1300 Houston, TX 77042 / (713)812-0800, whose officer residing in the State of Texas, authorized to accept service in all suits and actions brought within said state is Blaine Allen and whose address is 5930 Preston View Blvd., Ste. 200 Dallas, TX 54250, hereinafter called the Surety, and held and firmly bound unto, KP George, County Judge of Fort Bend County, Texas, or his successors in office, in the full sum of Five Hundred Sixty-Six Thousand Two Hundred Eighteen and 11/100 Dollars (\$566,218.11) current, lawful money of the United States of America, to be paid to said KP George, County Judge of Fort Bend County, Texas, or his successors in office, to which payment well and truly to be made and done, we, the undersigned, bind ourselves and each of us, our heirs, executors, administrators, successors, assigns, and legal representatives, jointly and severally, by these presents.

AND WHEREAS, the principal desires to provide Fort Bend County with a performance bond covering all such cable, conduit and/or pole line activity, commercial driveway and median openings or modifications;




