

## Power of Attorney

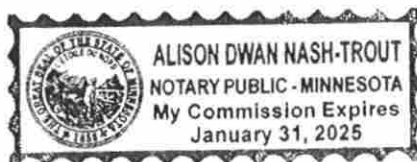
