**FIRST AMENDMENT TO  
 TEMPORARY EMPLOYMENT STAFFING SERVICE FOR CLINICAL HEALTH DEPARTMENT  
 GRANT FOR FORT BEND COUNTY  
 BID 19-064  
 (EXTENSION OF SERVICES)**

**THIS FIRST AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and A-1 Personnel Staffing of Houston, Inc. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Fort Bend County Bid 19-064 document (hereinafter collectively the "Agreement") on or about May 28, 2019 pursuant to execution by the Fort Bend County Judge; and

WHEREAS, the parties desire to extend the term of the Agreement in order to continue services.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. The Agreement is hereby renewed; effective as of July 1, 2020 through December 15, 2021 unless terminated sooner as provided for in the Agreement. All terms and conditions shall remain the same.
2. The Maximum Compensation payable to Contractor for all Services rendered shall be increased to an amount not to exceed the amounts certified to date by the Fort Bend County Auditor and additional amounts of funds from time to time certified available (if any).
3. In no case shall the amount paid by County for all Services under the Agreement and all executed Amendments exceed the Maximum Compensation without an agreement executed by the parties.
4. In the event of conflict the most recently executed document shall prevail with regard to the conflict.
5. Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the parties hereto have signed or have caused their respective names to be signed to multiple counterparts to be effective on the date signed by the final party.
