**AMENDMENT TO AGREEMENT FOR
 NUTRITION PROGRAM SUPPORT SERVICES
 TEXAS BLACK EXPO, INC**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Texas Black Expo, Inc., (hereinafter "Contractor"), a non-profit Texas corporation.

WHEREAS, the parties executed and accepted that certain Agreement for Nutrition Program Support Services on October 20, 2020, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to extend the Time of Performance and increase the total Maximum Compensation under the Agreement for the completion of such additional services to be provided thereunder.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional two million eight hundred thousand dollars and no/100 (\$2,800,000.00) to continue providing Services under the terms and conditions of the Agreement.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed five million six hundred thousand dollars and no/100 (\$5,600,000.00), authorized as follows:
 \$2,800,000.00 under the Agreement; and
 \$2,800,000.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
4. The parties agree the terms and conditions of the Agreement have remained in effect to date and are hereby extended to end no later than May 31, 2021.
