**AMENDMENT TO ADDENDUM TO A-ROCKET MOVING & STORAGE INC.'S AGREEMENT**

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and A-Rocket Moving & Storage, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Addendum to A-Rocket Moving & Storage, Inc.'s Agreement on or about September 22, 2020, in accordance with Buy Board Contract 559-18 (hereinafter "Agreement"), which was subsequently amended on or about October 27, 2020, which is incorporated by reference; and

WHEREAS, the parties desire to amend the Agreement to add additional services for the completion of the transport and delivery of voter equipment from the Fort Bend County Rosenberg Annex to various polling locations ("Services"), and to provide a new total Maximum Compensation.

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. County shall pay Contractor an additional sixty-nine thousand nine hundred seventy-five dollars and 00/100 (\$69,975.00) for additional transport and deliver services of voter equipment from the Fort Bend County Rosenberg Annex to various polling locations as described in the Contractor's Estimate dated March 12, 2021, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed one hundred thousand eighty-two, four hundred seventy and 00/100 (\$182,470.00), authorized as follows:  
                                   \$112,495.00 under the Agreement; and  
                                   \$ 69,975.00 under this Amendment.
3. In no case shall the amount paid by the County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further written agreement.

Except as provided herein, the parties agree that all terms and conditions of the Agreement dated September 22, 2020, shall remain in full force and effect as of that date and shall remain unchanged.
