**4. Public Comments regarding the Agenda and Announcements.**

Dr. Jacquelyn Minter updated the court on the COVID vaccine. The COVID new cases are under 100 new cases per day and the hospitalizations and deaths remain stable. There has been a shift in the percentage of age group, with the most infections, which are the 10-20 year olds. This is expected because older people are being vaccinated. The FDA has granted the first part of authorization for those parents and families who would like to get their 12-15 year olds vaccinated. The guidelines will be discussed in the coming days. There are about 51% of the Fort Bend County population who are fully vaccinated and 600,000 doses of the COVID vaccine has been administered.

There were three Proclamations:

Crossbridge Church was commended for helping 688 Fort Bend County residents pay a total of \$1.9 million in debt. Pastor Diego Armendariz and staff of Crossbridge Church received the proclamation. May 11, 2021 has been proclaimed as Crossbridge Church Day in Fort Bend County.

Judge George proclaimed May 6 - 12, 2021 as National Nurses Week in Fort Bend County. Dean Kathryn Tart, University of Houston College of Nursing and Barbarah Martinez, Fort Bend County Health & Human Services received the proclamation.

National Economic Development Week is May 9 - 15, 2021. The Economic Development helps the County grow and excel. Jerry W. Jones, Richmond Development Corp., Elizabeth Huff, City of Sugar Land and Rachelle Kanak, Fort Bend EDC received the proclamation.

The hurricane preparedness week is May 9 - 15, 2021. The hurricane season officially begins June 1 and will end November 30.

Judge George also recognized the month of May as Jewish American Heritage month, which recognizes the American Jewish contributions to our nation's history and the American culture.

Commissioner Prestage congratulated the Thurgood Marshall High School Girls Track and Field Team on winning the state championship.

NOW, THEREFORE, Fort Bend County Commissioners Court through a majority vote hereby appoints Mark Gibson to serve as Fort Bend County Justice of the Peace, Precinct 2, effective upon the resignation of Judge Joel C. Clouser, Sr., the appointee's subscribing to the official oath and delivery of a bond payable to the County Judge securing faithful performance of the appointee's duties to fulfill the vacancy in the office of Fort Bend County Justice of the Peace, Precinct 2 until the next general election.
