**AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL CONSULTING ENGINEERING SERVICES FOR
 SANITARY SEWER FORCE MAIN IMPROVEMENT PROJECT – CITY OF KENDLETON
 RFQ 20-065**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Kaluza, Inc., (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Consulting Engineering Services on July 20, 2020, (hereinafter “Agreement”); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Consultant an additional nine thousand three hundred seventy-five dollars and 00/100 (\$9,375.00) for additional services, as described in Consultant’s Invoice reflecting additional services attached hereto as Exhibit “A”; and
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed seventy thousand one hundred seventy-five dollars and 00/100 (\$70,175.00), authorized as follows:
 - \$60,800.00 under the Agreement; and
 - \$9,375.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

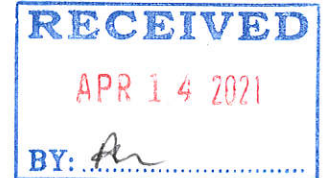


