**AMENDMENT TO AGREEMENT FOR  
 CONSTRUCTION MATERIALS OBSERVATION AND TESTING**

**THIS AMENDMENT**, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Raba Kistner, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Construction Materials Observation and Testing on May 26, 2020, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.


**NOW, THEREFORE**, the parties do mutually agree as follows:

1. The County shall pay the Contractor an additional sixty-seven thousand two hundred seventy-four dollars and 07/100 (\$67,274.07) for the additional services as described in the proposal dated April 19, 2021 attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered shall remain an amount not to exceed one hundred twenty-five thousand five hundred ninety-nine dollars and 07/100 (\$125,599.07), authorized as follows:
  - \$58,325.00 under the Agreement; and
  - \$67,274.07 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an amendment executed by the County and the Contractor.
4. Human Trafficking  
 BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and the Amendment shall remain unchanged.


