- Hiring new officers, including filling existing officer vacancies that are no longer funded in an agency's budget
- Rehiring officers already laid off as a result of state, local, or Bureau of Indian Affairs (BIA) budget reductions
- Rehiring officers scheduled at the time of the application to be laid off on a specific future date as a result of state, local, or BIA budget reductions

At the conclusion of the three-year project period, award recipients must retain all sworn officer positions supported through this program for a minimum of 12 months.

For FY 2021, priority consideration will be provided to projects that promote civil rights, increase access to justice, support crime victims, protect the public from crime and evolving threats, and build trust between law enforcement and the community. Additional consideration will also be given to applicants proposing a community-based approach to the following problem/focus areas:

- Building legitimacy and trust
- Violent crime/gun violence
- Combating hate and domestic extremism
- Police-based response to persons in crisis

Priority consideration will also be provided to applicants that meet the criteria detailed on pages 14-15 of the NOFA file.

Eligible costs may include reasonable steps to provide access to language-assistance services for individuals with limited English proficiency.

State, local, and university or college law enforcement agency applicants must be certified by an approved independent credentialing body, or have started the certification process, to be awarded as either a recipient or a subrecipient. Detailed information regarding this certification requirement is available online at cops.usdoj.gov.

Additional consideration will be provided to applicants:

- In an area with persistent poverty
- That commit to recruiting officers from the community in which they will serve
- That commit to recruiting officers who are willing to relocate to areas characterized by fragmented relations between police and community residents, or areas of high crime
- That require evidenced-based cultural sensitivity training for officers
- In states with certain anti-human trafficking laws that treat minors engaged in commercial sex as victims and permit individuals to vacate arrest or prosecution records for non-violent offenses as a result of being trafficked
- That have experienced an unanticipated catastrophic event or Attorney General-declared area in crime-related crisis
- That commit to hiring at least one military veteran
- From rural areas
- That did not receive an award through this program in FY 2020 due to the limited availability of funding

Summary: The purpose of this program is to enhance law enforcement's capacity to prevent, solve, and control crime by providing funds for the hiring of additional officers. The Winnebago County Forest Preserve District Police requested and received \$125,000 to hire one additional sworn officer to create flexibility in the schedule to allow for more police presence on the preserves in the after-hours and off months. The additional officer was requested to address ongoing issues with vandalism and destruction of preserves property. A local match of \$116,527 was provided to meet the remainder of the project cost.
