**FOURTH AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS FOURTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Amani Engineering, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on July 14, 2018, (hereinafter "Agreement") pursuant to SOQ 14-025, as amended by documents executed on September 4, 2018, (hereinafter "Amendment"), April 2, 2019, (hereinafter "Second Amendment"), and December 15, 2020, (hereinafter "Third Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional engineering services to be provided and increase the total Maximum Compensation for such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:


1. County shall pay Contractor an additional amount not to exceed seventeen thousand dollars and no/100 (\$17,000.00) to perform the additional Services, as described in Contractor's proposal dated April 27, 2021, attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed three hundred thirty-four thousand seven hundred ninety-one dollars and no/100 (\$334,791.00), authorized as follows:
 - \$212,468.00 under the Agreement;
 - \$65,424.00 under the Amendment;
 - \$32,778.00 under the Second Amendment;
 - \$7,121.00 under the Third Amendment; and
 - \$17,000.00 under this Fourth Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and any subsequent amendment exceed the Maximum Compensation without further written agreement executed by the parties.

4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and any subsequently executed amendment shall remain unchanged.

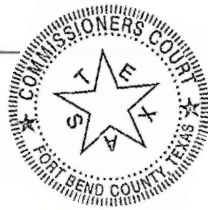
