- November 20, 2020 Mortgage file created/Saldana Clara/ 202408/amount = \$3,626.92.
- March 17, 2021 Clara Saldana called tax office to inquire about having penalty and interest waived since she did not receive statement due to mortgage company requesting statement. Clerk explained waiver procedure.

- March 18, 2021 –Received 2020 tax payment from Clara Luz Saldana in the amount of \$3,626.22, balance still owed on account.
- March 29, 2021 –Received 2020 tax payment from Clara Luz Saldana in the amount of \$327.14.
- March 31, 2021 Clara Saldana called to inquire about waiver of penalty and interest due to paying off mortgage and no longer escrowing taxes through mortgage company. Explained waiver procedure to Clara.
- April 13, 2021 County Judge received emailed request for waiver of penalty and interest for the 2020 Property Taxes.
