#### Precinct 4

Aisha Khattak, is requesting a waiver of penalty and interest for 2020 tax year providing a letter from Shellpoint Mortgage Servicing stating she paid her mortgage off with Shellpoint in October 2020 and was advised to contact the taxing authorities. However, she only contacted the Tax Office that collects Fort Bend County LID #2 and paid these taxes. She stated she was unaware that she was to contact two different offices to pay her taxes.

#### Tax Office records and research indicate:

August 31, 2020–2020 Tax Statement for account # 2305-01-000-0128-907 was
requested and sent electronically to Shellpoint Mortgage Servicing Per Property Tax
Code Section 31.01 (i-1) If an assessor mails a tax bill under subsection (a) or delivers a
tax bill by electronic means under subsection (k) to a mortgagee of a property, the
assessor is not required to mail or deliver by electronic means a copy of the bill to any
mortgagor under the mortgage or to the mortgagor's authorized agent.

- April 5, 2021 Aisha contacted the Fort Bend County Tax Office to discuss her
  delinquent tax account with our office stating she had previously contacted our office for
  a duplicate statement to be mailed to her. She was informed that she contacted the tax
  office that collects her LID taxes only which she stated she paid, in the amount of
  \$500.63. Our records do not reflect that we received a phone call from her in November
  2020 as she previously mentioned.
- April 5, 2021 County Judge received emailed request for waiver of penalty and interest for the 2020 Property Taxes.
- April 14, 2021 The Fort Bend County Tax Office received a check payment in the amount of \$7,570.53, including base levy with April penalty & interest.
- Ft. Bend ISD and City of Sugar Land have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the Texas Property Tax Code.

    - (1) the property for which the tax is owed is subject to a mortgage that does not require the owner of the property to fund an escrow account for the payment of the taxes on the property;
    - (2) the tax bill was mailed or delivered by electronic means to the mortgage of the property, but the mortgage failed to mail a copy of the mail to the owner of the property as required by Section 31.01(j);
