The County is authorized (i) to enter into the Joint Project Agreement; (ii) to pay the costs of issuance related thereto, and (iii) to secure the Bonds in the manner contemplated by the Order.
- 3) The Authority was duly created by the Commissioners Court of Fort Bend County ("Governing Body") on June 8, 2010 on behalf of the County and the Articles of Incorporation and the Bylaws, as amended on May 27, 2014, of the Issuer in effect on this date have not been further amended since.
- 4) The Order of the Governing Body authorizing the creation of the Issuer has not been amended, annulled, rescinded or revoked and remains in full force and effect on the date hereof.
- 5) No litigation is pending or, to the best of my knowledge after reasonable investigation, threatened against the Governing Body of the Authority:
 - i. To restrain or enjoin the issuance or delivery of the Bonds; or
 - ii. In any way contesting (a) the right and power of the Governing Body or the Authority in connection with any action taken by it towards the creation of the Issuer or the issuance of the Bonds or (b) the titles of the current County Commissioners or officers of the Fort Bend County Commissioners Court or their respective offices; or
 - iii. Contesting the execution or delivery of the Joint Project Agreement.

- 6) The Governing Body of the County certifies that it has approved the issuance and delivery of the Bonds and that the County is not currently in default of in any material respect under the Agreement (as defined in the Resolution), as supplemented.
- 7) The County meets the requirements under Section 284.002 of the Transportation Code because it is adjacent to a county (Harris County) that has a population of two million or more.
