# THIRD AMENDMENT TO WORK AUTHORIZATION NO. 6 TO AGREEMENT FOR PARK AND RIDE FACILITY PLANNING AND CONSULTING SERVICES SOQ 09-072

WHEREAS, the parties executed Work Authorization No. 6 on or about December 15, 2020, and as amended on February 2, 2021 and March 23, 2021, incorporated herein by reference; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

### **NOW, THEREFORE,** the parties do mutually agree as follows:

- 1. Exhibit B of the Agreement "Work Schedule" will be replaced with the attached Exhibit B "Revised Work Schedule".
- 2. Human Trafficking. BY ACCEPTANCE OF CONTRACT, CONTRACTOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of the Agreement. If there is a conflict between this Third Amendment and the Agreement for Professional Services, the provisions of this Third Amendment shall prevail with regard to the conflict.
