4. Public Comments regarding the Agenda and Announcements.

Judge George acknowledged Eid al-Adha, a Muslim holiday, will be celebrated on Tuesday, July 20, 2021. This holiday has been observed for many centuries and is a time of joy and blessings for the Muslim community.

Item 4 continued - Public Comments:

Mark Flathouse, Office of Emergency Management gave a weather update to the court. The Gulf and the Atlantic are calm. His team has been training with County departments and with the Drainage Department. They are continuing to make sure the County is prepared for Hurricane season.

Dr. Jacquelyn Minter, Director of Health & Human Services stated this week the Delta variant results have been quantified as being present in our community. It takes between 10 - 21 days to gain evidence of increasing viral activity. The case counts are slightly up in Fort Bend County and the Houston region. For the first time in 7 weeks, hospitals and testing sites are reporting a small but steady 14 day rise in test positivity at about 5% and the ICU admissions are up. Although, death rates have slowed greatly, we know the vast majority, almost 98%, are occurring in those who are unvaccinated. Deaths are a lagging indicator and we must wait to determine whether these deaths will rise due to the presence of the Delta variant. These statistics are disappointing; but are not surprising and it is what we must expect as we continue to coexist with the SARS-CoV-2 virus. Our community has benefited from a population that is willing to be vaccinated to provide protection for themselves and our community in order to function safely as we did prior to the pandemic. We are not free from the effects of the virus. Like all living things, this virus will continue to adapt in order to survive. Dr. Minter stated she appreciates the support in testing, in surveillance and monitoring efforts that allows us to inform the community at the earliest possible time in order for people to make decisions in taking steps to protect themselves. In the coming months, we are likely to see fluctuations in cases as new variants emerge, the characteristics in how fast they spread, what populations they affect and how well our vaccines will work. The Federal Government has provided funding to support efforts to provide vaccines to all eligible people who want the vaccine, which will help to reduce the circulation of the new variants and diminish the potential for new variants. The investment the court has made in the mobile health unit has allowed us to advertise the locations and hours free vaccines will be provided to those who want them in various areas of the County. To date, 8,000 vaccines have been administered in these outreach efforts. Dr. Minter stated she appreciates concerns of our neighbors and friends who do not want unsolicited visits regarding the vaccines. One of the performance measures in the federal funding requires the County to address the need for appropriate communication methods to be provided to ensure that all in our community have the opportunity to receive information and make informed decisions about their health and the health of their family. Research in the communication methods will help us determine what messages are important to people and how they want their information delivered. It is important to remember, every investment in our public health response today builds better tools to respond in the future.

There were a total of 31 public participants. Due to the large number of participants, only 9 were able to speak.

The Public Participants who spoke were:

1. Rebecca Clark, 7408 Kelsey Lane, Richmond is against Item 22C. Ms. Clark stated there is no science or data that the COVID vaccine is safe and effective and believes the outreach program will only coerce people into submission. Ms. Clark stated this is a violation of the fourth amendment and a waste of taxpayer money.
2. Jen Byrnes, is against Item 22C. Ms. Byrnes stated this vaccine program is a vaccine overreach, she asked if people's information would be put in a database for future reference. She believes the outreach program is unnecessary.
3. Christopher Heasley, 12110 Meadow Valley Lane, is against Item 22C, Door to Door Vaccine Outreach. Mr. Heasley stated the County court instructed medical interventions without understanding the complexities of medical science or the legal consequences.

Item 4 continued - Public Comments:

4. Kelley Bingham, 707 Arlington Lane, Rosenberg is against Item 22C and believes the outreach program is overreaching and the company being used is not trained in answering medical questions; but trained in data collection.
5. Bonnie Anderson, 27722 Cold Spring Trace, Katy is against Item 19A. Ms. Anderson stated the County will spend \$2,000,000 to hire medical professionals and believes this should not be under the government's purview.
6. Dr. Faisal Masud, 309 Gentilly Place, Houston, Medical Director for the Center for Critical Care, Houston Methodist Hospital spoke on Item 22C. Dr. Masud has seen the devastation of the COVID-19 disease and believes it is important to empower citizens with the best information to make good decisions. He stated that recent reports indicate over half of those not vaccinated earn less than \$50,000, and another study states with the vaccination effort about 279,000 lives have been saved through July.
7. Pastor David Sincere, 10402 Deer Branch, Missouri City, Fort Bend Transformation Church is for Item 22C.
8. Reverend Will Starkweather, 16318 Elmwood Point, Sugar Land, St. Martin's Lutheran Church spoke for Item 22C. Reverend Starkweather stated everyone has a right to refuse a vaccine and we also have a responsibility to our neighbors to those who do not have the same access and to those who have not received the same information. This grant is to provide people information and to make opportunity for those who have not had equal access to it and the grant is not forcing anyone to have the vaccine; but is providing the opportunity for these Americans to exercise their freedom and accept or deny a vaccine.
9. Richard Morrison, 1214 Oak Elm Lane, spoke for Item 22C. Mr. Morrison stated this is not a forced vaccination campaign. There are people in this community who are not as well informed as others and should be the ones this program will target.

Item 4 continued - Public Comments:

Commissioner Meyers read a letter, in court, received from Senator Lois Kolkhorst and State Representative Jacey Jetton.

To Judge George and the Fort Bend County Commissioners:

With the introduction of the COVID Vaccine, Fort Bend initially lagged behind other counties in the vaccine allocations we received. Demand for the vaccine at that time was high and we worked with Governor Abbott, Texas Department of State Health Services, and local partners to increase this allocation, ensuring the people of Fort Bend could be vaccinated. Through community partners like Access Health, Memorial Hermann, Methodist and many others, Fort Bend County can now boast of some of the highest vaccination rates in the nation, particularly among those over 65 years old. The world-class nonprofit organizations serving Fort Bend have organized dozens of vaccination events, educational events, and distributed information to our highest risk communities, the very communities where they have spent decades cultivating relationships and understanding.

Despite our record high vaccination rates, the Fort Bend Commissioners Court shared concerns about pockets of individuals throughout the county who have not yet received the vaccine. While we are committed to the freedoms that define America, including an individual's right to refuse vaccination, we also want to ensure any individual who wants to receive a vaccine is able to do so.

We encourage the Fort Bend Commissioners to continue partnering with the non-profit organizations that are trusted by all individuals in our community to ensure everyone in Fort Bend has access to a COVID vaccine. When this Commissioners Court brought in for-profit, political, consulting firms in response to the COVID pandemic, the non-profit organizations were directly harmed. They received less cooperation, funding, and communication than in past disasters. They also had a more difficult time working with the consulting firms and Fort Bend than other counties of similar size and demographics.

For-profit, third party, political consulting firms are detrimental to Fort Bend and to the non-profit organizations that are most trusted by our at-risk communities. We strongly encourage the Commissioners Court to oppose any further cooperation with these firms and commit our time and energy to working with your offices and our nonprofits to ensure Fort Bend families have access to vaccinations.

Dr. Jacquelyn Minter, Director of Health & Human Services gave an overview of this program. A team was put together to review proposals on communication activities in order to reach the most vulnerable populations. The team felt it was important to be able to communicate effectively with those populations who want the vaccine but are not able to get the right information. This included multilingual information, being able to talk to different community groups and see how to provide information to people who want the information to make good decisions about getting their vaccines.

Commissioner Morales stated, while I support all efforts to provide information, access and options available to Fort Bend County residents concerning the availability of various COVID 19 vaccines, I cannot support the unnecessary government intrusion into the private lives of our citizens that this proposal would undoubtedly cause. Additionally, any consultant hired to advise the residents of Fort Bend County as to the pros and cons of vaccination for the COVID 19 virus should have a medical background that would ensure that the consultant has the requisite expertise to competently advise our citizens of the potential risks involved so that they may make an informed decision as to their family's healthcare needs.

Commissioner Meyers commented that Dr. Minter's Office has done an outstanding job in communicating with the entire community including those at risk community and nonprofits, including churches, and with the mobile health unit going out to the communities. These efforts have reflected with Fort Bend County ranking 2nd or 3rd in the state out of 254 Counties. Why spend \$345,000 if we are doing an outstanding job. This selected firm is a political operative and generates a database of personal contact information of voters for campaigns in the future, since this firm is also a campaign consultant. Commissioner will not be supporting this item.

Judge George read a statement. As we have heard from time to time Dr. Minter say, we are leading our region in percentage of population with vaccines being administered. This happened because of the continuous outreach from various organizations, nonprofit organizations and each of our offices. Because of this success, Fort Bend County is almost back to normal. Although 65% of our residents are vaccinated, 12 years and older, there are still 35% (200,000 people) who are not vaccinated. As the Delta variant progresses, we have learned 99% of those who die from this aggressive variant are unvaccinated. There is an urgency to do everything we can to educate and inform our community members, specifically those who are most vulnerable in our communities in order that they make an educated decision about getting vaccinated. Judge does support this item.
