SUPPLEMENTAL AGREEMENT NO. 6 TO AGREEMENT OF JANUARY 24, 2017 FOR VIOLATIONS PROCESSING SERVICES AGREEMENT

THIS SUPPLEMENTAL AGREEMENT is made and entered into on July 21, 2021, and modifies the VIOLATION PROCESSING SERVICES AGREEMENT dated January 24, 2017 (the "Agreement") by and between the Fort Bend Grand Parkway Toll Road Authority, a Texas Local Government Corporation (the "Authority"), and SWC Group, LP a Texas limited partnership (herein called "SWC").

The Agreement is hereby modified as follows:

1. In accordance with Section 2.01 of the Agreement, the Authority and SWC approve a revised Compensation for Services and Payment Schedule shown on the attached Exhibit E, which replaces the prior Exhibit E.

In accordance with Section 3.01 of the Agreement, the Authority hereby exercises the second of two options to extend the Agreement for one year, extending the time for SWC's performance of the Services under this Agreement to September 30, 2022.

This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.
