**ORDER AUTHORIZING SETTLEMENT OF CONDEMNATION SUIT**

On this 27<sup>th</sup> day of July, 2021, the Commissioners Court of Fort Bend County, Texas, being convened at a regular meeting of the Court, sitting as the governing body of Fort Bend County, upon motion of Commissioner Morales, second by Commissioner Pustage, duly put and carried, IT IS HEREBY ORDERED that:

The County Attorney is hereby authorized to accept the landowner's offer to jointly move for an *Agreed Judgment on the Award* pertaining to the following cause number:

***Cause #20-CCV-067563 - Fort Bend County, Texas vs. FBRE I, LP, et al;  
Bamore Road Project #17105, Parcel #1, Precinct 1***

The cash component of the *Agreed Judgment on the Award* will be \$83,000.00 with credit for the principal amount of \$73,200.00 already on deposit with the Clerk of the Court in said cause for the benefit of the defendants.

It is further ordered that *Order #36A*, signed on July 7, 2020, authorizing litigation expenses in the amount of \$10,000.00 (copy attached as Exhibit "A" for reference) be increased to permit the expenditure of up to but not exceeding the total sum of \$10,750.00, of which \$750.00 is new money for additional litigation expenses.

And that account #**762622888 63000 P622-18BAMORE2** be designated as the funding source.
