Odyssey Engineering Group, LLC. is preparing a driveway permit application to submit to the Texas Department of Transportation (TxDOT) for the proposed street tie-in of a minor collector road to Farm to Market 2977 (Minonite Road). The proposed connection will be located approximately 2,500 linear feet southwest of the intersection of Koeblen Road and Farm to Market Road 2977 (Minonite Road) and will be used as one of two entry roads to the proposed development named Windstone on the Prairie.
