POTENTIAL CHANGE ORDER DESCRIPTION: (The Contract Is Changed As Follows)

CE #001 - Overnight Hours

In order to mitigate public intereference with the project, Owner has requested to complete the project overnight. This Change Event identifies the price modifications to accommodate the overnight working hours.

CE #002 - Concrete Slab_Option #1_Cement Stabilized Base

The Owner redesigned the concrete slab to better support the monument in its new location. Option #1 design is for a cement stabilized sand concrete slab that is 7' x 7' and 3' below grade at the stirrups and 2' foundation.

CE #004 - Existing Cemetery Fence Removal

The new location where the monument is to be placed at the cemetery has an existing chain link fence with foiliage that was identified post award. This fence is to be removed in order to place new anti-climb fencing.

CE #005 - Anti-Climb Steel Fence Material Escalation

Due to current market conditions and supply chain issues, prices for steel have significantly increased and supplier pricing is not guaranteed for longer than 24 hours. This escalation is a relection of the updated pricing of materials since this project was originally bid.
