**THIS AMENDMENT** is made and entered into between **Fort Bend County**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease to extend lease term.


NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution by the Government as follows:

1. TO HAVE AND TO HOLD the Government hereby leases the said premises with their appurtenances for the term beginning **September 1, 2021** through **August 31, 2023**.
2. The Government will pay the Lessor annual rent of **\$89,482.25** payable at the rate of **\$7,456.85** per month representing **\$16.34/SF** per **5,476** rentable square feet (RSF) in arrears.
3. All rights and responsibilities and obligations that bind the Lessor and Government under this lease agreement, including the General Clauses and any other attachments hereto, shall pertain to the entire space under this lease, including any free space. The lessor must have an active/updated registration in the System for Award Management (SAM) System (<https://www.sam.gov>) upon receipt of this Lease Amendment. The Government will not process rent payments to Lessors without an active/updated beta.sam registration.
