FIRST AMENDMENT TO ADDENDUM AND AGREEMENT WITH THE BRANDT COMPANIES, LLC FOR HVAC SERVICES

NOW PURSUANT TO CHOICE PARTNERS CONTRACT NUMBER 19/036MR-05

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and The Brandt Companies, LLC, ("Brandt Companies"), a company authorized to conduct business in the State of Texas (hereinafter collectively referred to as the "parties").

WHEREAS, the parties executed and accepted that certain Agreement and Addendum on August 8, 2021 (hereinafter "Agreement") which is incorporated by reference; and

WHEREAS, the parties desire to amend the Agreement to include additional HVAC Services that have been competitively procured pursuant to Choice Partners Contract Number 19/036MR-05, which will increase the total Maximum Compensation under the Agreement for the completion of such additional services to be provided thereunder.

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional \$11,055.00 to provide the additional HVAC Services, under the terms and conditions of the Agreement and as described in the attached and incorporated Exhibit.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed \$57,920.00, authorized as follows:

\$46,865.00 under the Agreement; and \$11,055.00 under this Amendment.

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
