FY 2022 EXTENSION FOR FACILITIES CAMERA SYSTEM AGREEMENT (MAINTENANCE) RFP 13-044

THIS FY 2022 EXTENSION is entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and 911 Security Cameras, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

THAT, WHEREAS, the parties executed and accepted that certain Agreement for Facilities Camera System on June 4, 2013, and then subsequently extended the agreement (for labor and maintenance) on July 9, 2013; October 7, 2014; September 22, 2015; August 9, 2016; September 5, 2017; July 24, 2018; September 24, 2019, and on September 22, 2020 (hereinafter collectively referred to as "Agreement" and incorporated by reference); and

WHEREAS the Agreement provided for the purchase of facilities-wide Video Security Systems and each subsequent extension provided for labor, maintenance and support for those Video Security Systems; and

WHEREAS the parties desire to again extend the Agreement for labor, maintenance and support;

NOW, THEREFORE, County and Contractor do mutually agree as follows:

- 1. The labor and maintenance services as detailed in the Labor and Maintenance Agreement, attached hereto as "Exhibit A", shall be extended for an additional one-year term starting on October 1, 2021 and ending on September 30, 2022.
- 2. The Maximum Compensation for the performance of Services as described in Exhibit A is fourteen thousand one hundred fifty-seven dollars and no cents (\$14,157.00). In no case shall the amount paid by County under this extension exceed the Maximum Compensation without an approved written amendment.
- 3. Prohibited Telecommunications and Video Surveillance Services and Equipment. Contractor understands and acknowledges that under 2 CFR 200.216, the County is prohibited from using federal funds to procure, obtain, extend or renew a contract to procure or obtain covered telecommunications equipment or services, including telecom equipment produced by Huawei Technologies Company or ZTE Corp. (or subsidiaries or affiliates of such entities).

Contractor, therefore, certifies that they are in compliance with the John S. McCain National Defense Authorization Act for Fiscal Year 2019 (FY 2019 NDAA), Pub. L. No. 115-232 (2018), and that in the performance of this agreement, it will not provide

equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. As described in Public Law 115-232, section 889, covered telecommunications equipment is telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).

- (i) For the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any <u>subsidiary</u> or affiliate of such entities).
- (ii) Telecommunications or video surveillance services provided by such entities or using such equipment.
- (iii) Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country.
- 4. BY ACCEPTANCE OF CONTRACT, CONTRACTOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement, including any addenda, amendments, or extensions not modified shall remain in full force and effect. If there is a conflict between this Extension and the Agreement, the provisions of this Extension shall prevail with regard to the conflict.
