**4. Public Comments regarding the Agenda and Announcements.**

Judge George encouraged members of the court and County employees to attend a ceremony after court and to sign the beams of the new building for the Office of Emergency Management. Judge also announced the State of the County event will be on Thursday, October 14 at 11:00 AM.

Dr. Jacquelyn Minter, Director of Health and Human Services gave an update on COVID in Fort Bend County. An average of 165 new cases of COVID per day were recorded last week. Hospitalizations and ICU average 108 patients per day, which is a decrease of 59 patients compared to the average of the previous month. The 7- day percentage of ICU patients being admitted for COVID is 18%. The test positivity for local hospitals and from the County's testing sites have fallen just below 10%. An additional 23 deaths were confirmed during the reporting week. There are over 900 lives lost locally due to COVID in the past year and a half. The decrease in cases and hospitalizations continue in Fort Bend County and across the Region. In approximately 3 months, April to July, Fort Bend County experienced 2,905 PCR confirmed cases and 42 deaths. After the arrival of the Delta Variant, from July to October, the County experienced 22,251 cases and 164 deaths. The impact has been greater on unvaccinated residents. COVID has taught us humility, as we respect the changes in the way the virus affects our community. However, we continue to have tools at our disposal to be safer.

Roger Adamson, CEO of The George Foundation, 7218 Foster League, spoke on Agenda Item 29E, the road development agreement between Fort Bend County and Rosenberg Land Holding LLC. Mr. Adamson provided additional information and facts with respect to Agenda Item 29E.

Stephen Robinson, General Counsel, East Fort Bend County Development Authority, on behalf of Signorelli Companies, spoke in favor of Agenda Item 29E.

Tami Frazier, Communications Director for the Office of the County Judge presented a Proclamation to the family of Koshy Thomas who passed away recently. Sincere sympathy was extended to the Thomas family. Mr. Thomas was the owner and publisher of Voice of Asia News Group.
