AMENDMENT AND RENEWAL OF AFFILIATION AND PROGRAM AGREEMENT FOR COURSE EXPERIENCE BETWEEN FORT BEND COUNTY AND WHARTON COUNTY JUNIOR COLLEGE

THIS AMENDMENT is made and entered into is entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Wharton County Junior College, (hereinafter "School"), a public institution of higher learning (hereinafter collectively referred to as the "Parties").

WITNESSETH

WHEREAS, County and School executed the Affiliation and Program Agreement for Course Experience Between Fort Bend County and Wharton County Junior College on or about January 26, 2021, (hereinafter the "Agreement"), hereto incorporated by reference as if set forth herein verbatim.

NOW, THEREFORE, County and School desire to amend said Agreement as set forth below:

- A. The Agreement is hereby renewed for one (1) more year; effective as of September 1, 2021, and shall automatically renew each year for five (5) years until August 31, 2026. It is expressly understood and agreed to by the Parties that the period or term of this Agreement may be terminated without cause at any time by either party giving to the other party at least thirty (30) days advance written notice of its intent to terminate, specifying in the notice the effective date of the termination. Such notice shall be given by certified mail, return receipt requested, and shall be effective when mailed to the address stated herein.
- B. Notice to Parties
 - a. Any notice given hereunder by either party to the other shall be in writing and sent by certified mail, return receipt requested.
